NARRATIVE

ON 09/06/2018, AT 1004 HOURS, I OBSERVED A WHITE NISSAN PICKUP TRUCK BEARING FLORIDA TAG (#IRYH79), TRAVELING NORTHBOUND IN THE 2500 BLOCK OF GULF DRIVE. UPON RUNNING THE TAG THROUGH FCIC/NCIC, IT WAS DETERMINED THE REGISTERED OWNER OF THE VEHICLE HAD MULTIPLE SUSPENSIONS ON HIS DRIVERS LICENSE. THE FIRST SUSPENSION WAS ON 11/24/2017 FOR DUI (REFUSAL TO SUBMIT). THE OTHERS BEING 07/24/2018 AND 09/04/2018. I WAS ABLE TO IDENTIFY THE DRIVER AS THE OWNER OF THE VEHICLE FROM THE PICTURE PROVIDED THROUGH FCIC/NCIC. I THEN CONDUCTED A TRAFFIC STOP IN THE 3400 BLOCK OF EASTBAY DRIVE. UPON ASKING THE DRIVER FOR HIS LICENSE, REGISTRATION, AND PROOF OF INSURANCE, THE DRIVER ADVISED HE DID NOT HAVE A LICENSE DUE TO IT BEING SUSPENDED. THE DRIVER (JOHN WATKINS), WAS EXTREMELY COOPERATIVE THROUGHOUT MY ENCOUNTER. DUE TO THE (WATKINS) DRIVING ON A SUSPENDED LICENSE (3RD OR SUBSEQUENT OFFENSE), I PLACED WATKINS INTO HANDCUFFS (DOUBLE LOCKED) AND PLACED HIM INTO MY PATROL VEHICLE. A TOW INVENTORY WAS COMPLETED ON THE VEHICLE AND IT WAS REMOVED FROM THE SCENE BY BAKERS TOWING. I THEN TRANSPORTED WATKINS TO THE HOLMES BEACH POLICE DEPARTMENT WHERE I COMPLETED THE NECESSARY ARREST PAPERWORK FOR DRIVING WHILE LICENSE SUSPENDED (3RD OR SUBSEQUENT OFFENSE) AND THEN TRANSPORTED WATKINS TO 75TH AND MANATEE WHERE HE WAS TURNED OVER TO A MANATEE SHERIFFS OFFICE DEPUTY FOR TRANSPORT TO THE JAIL.

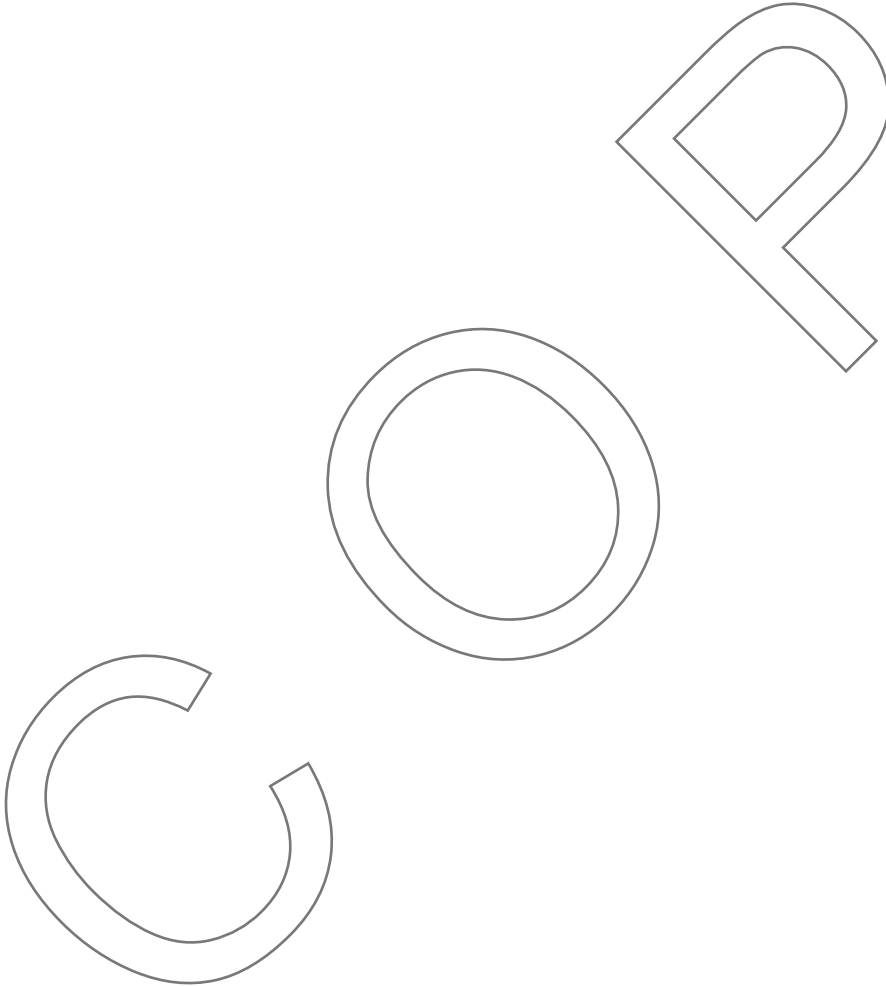

OFFICER M. WALKER CONDUCTED A TRAFFIC STOP ON A WHITE NISSAN TITAN TRUCK OPERATED BY JOHN MARK WATKINS. HAVING A FELONY STATUS LICENSE SUSPENSION, HE WAS SUBSEQUENTLY ARRESTED FOR OFFENSE. PASSENGER, THE AFOREMENTIONED WAS SWEATING PROFUSELY AND I EXPLAINED TO HER THAT THE VEHICLE WAS GETTING TOWED FROM THE SCENE AND SHE NEEDED TO VACATE THE TRUCK. THE AFOREMENTIONED WALKED OUTSIDE THE VEHICLE AND THERE WAS A LARGE BROWN WOMEN'S PURSE LAYING ON THE FLOORBOARD WHERE HER FEET WERE--IN IMMEDIATE POSSESSION.

I ASKED HER IF THIS WAS HER PURSE AND SHE REPLIED, "YES." SHE SAID, "YOU CAN SEARCH IT--IF YOU WANT." I OBLIGED AND DURING THE SEARCH I FOUND A CUT PLASTIC STRAW IN HER WALLET, HOWEVER THERE WAS NO RESIDUE ON OR INSIDE OF IT. 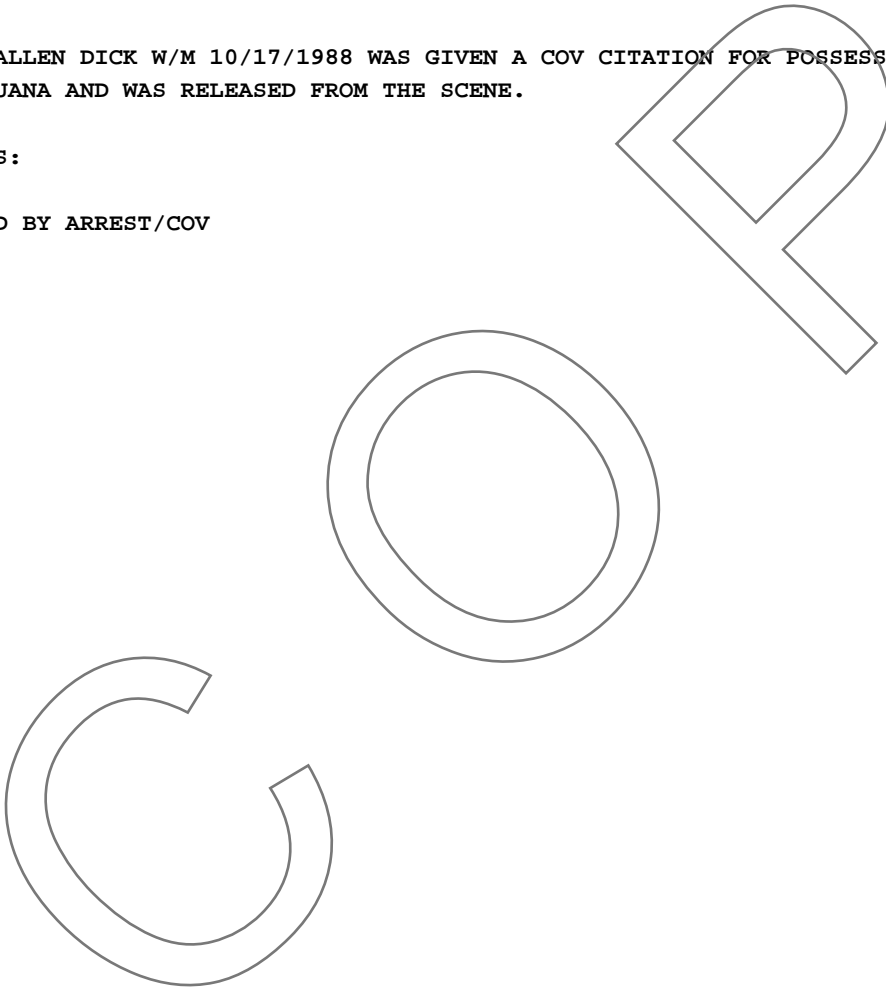

NARRATIVE

ON 09/08/18, SGT. J. PIERCE REQUESTED BACKUP FOR A TRAFFIC STOP HE HAD JUST CONDUCTED. I ARRIVED ON SCENE, AT 6401 MARINA DRIVE, WITHIN A MINUTE OR TWO. WHEN I ARRIVED, I OBSERVED SGT. PIERCE WITH A SUBJECT, LATER IDENTIFIED AS THE DEFENDANT (NICKOLAS GUERRA), STANDING OUTSIDE OF THE STOPPED/PARKED VEHICLE. I OBSERVED (GUERRA'S) EYES TO BE BLOOD SHOT AND WATERY. I SMELLED AND ODOR OF ALCOHOLIC BEVERAGE COMING FROM ON/AND OR ABOUT (GUERRA'S) PERSON. (GUERRA) HAD AN ATTITUDE AND WAS AGITATED. (GUERRA'S) SPEECH WAS SLIGHTLY SLURRED, SOME OF HIS STATEMENTS WERE CONFUSING AND HE WOULD REPEAT STATEMENTS. (GUERRA) WAS WEARING SNEAKERS, BLUE JEANS WITH THE FRONT CROTCH ZIPPER DOWN AND A GREEN T-SHIRT THAT HAD A MARIJUANA PLANT ON THE FRONT OF IT. (GUERRA) WAS SWAYING WHILE HE WAS STANDING, WIDENING HIS STANCE TO ATTEMPT TO HELP HIS BALANCE. (GUERRA) RESTED AGAINST THE VEHICLE A COUPLE TIMES TO ASSIST HIS BALANCE. (GUERRA) STATED HE WAS AWARE THE TIRE WAS FLAT. (GUERRA) STATED HE GOT HOME SAFELY AND DID NOT THINK IT WAS A BIG DEAL ON THE ISLAND.

(GUERRA'S) MOTHER AND FATHER CAME OUTSIDE WHILE WE WERE ON SCENE. THEY WERE ARGUMENTATIVE AND HAD TO BE COMMANDED SEVERAL TIMES TO STAY BACK AND NOT INTERFERE. WHILE STANDING NEXT TO, OUTSIDE OF, THE CLOSED DRIVER DOOR, I OBSERVED SEVERAL SMALL BURNT HAND ROLLED JOINTS IN PLAIN SIGHT. THIS OFFICER'S TRAINING AND EXPERIENCE LEAD ME TO BELIEVE THESE WERE HAND ROLLED MARIJUANA JOINTS, ALSO KNOWN AS ROACHES. I ADVISED SGT. PIERCE AND CONDUCTED A CHECK OF THE ITEMS. WHEN I OPENED THE DRIVER DOOR, I DETECTED A STRONG ODOR OF MARIJUANA COMING FROM INSIDE THE VEHICLE. I OBSERVED A BURNT HAND ROLLED JOINTS ON THE DRIVER SEAT, UNDER THE DRIVER SEAT AND ON THE PASSENGER SEAT. I OBSERVED A GREEN LEAFY SUBSTANCE INSIDE THE BURNT HAND ROLLED JOINTS AND THEY HAD A STRONG ODOR OF BURNT MARIJUANA. I CONDUCTED A SEARCH OF THE VEHICLE AND DISCOVERED A PROJECTILE TASER IN A HOLSTER, DIRECTLY BEHIND THE CENTER CONSOLE, WITHIN THE DRIVER'S REACH, READILY AVAILABLE. I DISCOVERED A HALF FULL COLEMAN FLASK, OF WHAT HAD A STRONG ODOR OF AN ALCOHOLIC BEVERAGE INSIDE. THIS FLASK WAS FOUND IN A FRONT POUCH OF A BACKPACK, LOCATED DIRECTLY BEHIND THE DRIVER SEAT. THERE WERE COLOGNE BOTTLES AND DEODORIZING BODY SPRAYS INSIDE THE DRIVER DOOR AND CENTER CONSOLE. THERE WERE CIGARETTE CONTAINERS ALL OVER THE VEHICLE. (GUERRA) HAD AN ELECTRONIC HAND HELD VAPOR ON HIS PERSON, THAT HAD WHAT APPEARED TO BE CBD OIL INSIDE. I COLLECTED THE EVIDENCE. (GUERRA) WAS BEING BELLIGERENT, STATING THE MARIJUANA WAS ONLY A CITY ORDINANCE VIOLATION, DEMANDING WE GIVE HIM THE CITATION AND LEAVE. (GUERRA'S) PARENTS ATTEMPTED TO CLAIM THE MARIJUANA, STATING IT WAS FOR (GUERRA'S) FATHER'S CANCER.

DUE TO THE AGITATED SCENE, SGT. PIERCE AND I DETERMINED THE STANDARDIZED FIELD SOBRIETY EXERCISES WOULD BE BETTER SUITED TO CONDUCT AT THE STATION. (GUERRA) WAS ARRESTED AND TRANSPORTED TO THE HBPD STATION.

(GUERRA) CONSENTED TO CONDUCT THE FIELD SOBRIETY EXERCISES. (SEE THE DUI PACKET AND NARRATIVE PAGE WITH THE SFST BREAKDOWN).

NARRATIVE

ON 09-08-18 WHILE STATIONARY AT THE 5900 BLOCK OF MARINA DR I HEARD A VERY LOUD SCRAPING/Dragging SOUND TRAVELING NORTH ON MARINA DR. I OBSERVED THE NOISE COMING FROM A GREY CHEVY SEDAN TRAVELING NORTH. AS IT PASSED ME I OBSERVED THE VEHICLE TO HAVE A FLAT FRONT PASSENGER SIDE TIRE. THE TIRE WAS SO FLAT THAT IT HAD SHREDDED AND WAS TRAVELING ON THE RIM AT TIMES. THE VEHICLE WAS TRAVELING APPROXIMATELY 15 MPH IN A 35 MPH ZONE. I PULLED BEHIND THE VEHICLE (FL TAG #JFFU69) AND ACTIVATED MY EMERGENCY LIGHTS TO CONDUCT A TRAFFIC STOP. THE VEHICLE THEN PULLED INTO A DRIVEWAY AT 6401 MARINA DR. THE DRIVER, LATER IDENTIFIED AS THE REGISTERED OWNER (NICKOLAS BILL GUERRA) EXITED HIS VEHICLE AND BEGAN TO WALK TOWARDS A RESIDENCE LATER DETERMINED TO BE HIS. I GAVE GUERRA VERBAL COMMANDS TO STOP AND GET BACK INSIDE THE VEHICLE AND HAD TO RUN AFTER HIM TO PREVENT HIM FROM GOING INSIDE THE HOME. I HAD TO PHYSICALLY ASSIST HIM AND REDIRECT HIM TO THE DRIVER SIDE OF THE VEHICLE AFTER GIVING HIM SEVERAL VERBAL COMMANDS TO RETURN TO THE VEHICLE OF WHICH HE FAILED TO COMPLY WITH. HE SPONTANEOUSLY UTTERED THAT HE HAD MADE IT ALL THE WAY HOME ON A FLAT TIRE. WHILE WALKING HIM BACK TO THE DRIVER SIDE OF THE VEHICLE HE WAS VERY UNSTEADY ON HIS FEET AND FUMBLING HIS FEET WHEN HE WALKED NEARLY TRIPPING.

I IMMEDIATELY OBSERVED A VERY STRONG ODOR OF ALCOHOL COMING FROM HIS PERSON. HE WAS SWEATING PROFUSELY. HIS EYES WERE EXTREMELY BLOODSHOT AND WATERY. I COULD ALSO SMELL A VERY STRONG ODOR OF MARIJUANA COMING FROM HIS PERSON. GUERRA APPEARED TO BE INTOXICATED AND UNDER THE INFLUENCE OF BOTH ALCOHOL AND CANNABIS. HE SWAYED BACK AND FORTH NUMEROUS TIMES. I OBSERVED A BULGING OBJECT IN HIS FRONT PANTS POCKET AND AFTER GUERRA FAILED TO COMPLY WITH SIMPLE COMMANDS I PATTED HIM DOWN FOR WEAPONS. THE OBJECT IN HIS POCKET WAS CANNABIDIOL (CBD OIL) AND A VAPE USED FOR SMOKING THE CONCENTRATED CBD OIL. GUERRA DOES NOT HAVE A MEDICAL PRESCRIPTION FOR CBD OIL. OFFICER DESANTIS THEN ARRIVED ON SCENE. OFFICER DESANTIS POINTED OUT THAT IN PLAIN VIEW HE OBSERVED NUMEROUS MARIJUANA JOINTS IN THE DRIVER SIDE DOOR HANDLE CUT OUT. I ADVISED OFFICER DESANTIS TO SEIZE AND SECURE THE MARIJUANA JOINTS AND CONDUCT A FURTHER SEARCH OF THE VEHICLE. THE PARENTS OF GUERRA CAME OUTSIDE AND BEGAN A SHOUTING MATCH WITH OFFICERS AND HAD TO BE REDIRECTED SEVERAL TIMES TO STEP AWAY FROM THE VEHICLE AND TO STOP INTERFERING. GUERRA'S SPEECH TO ME THROUGHOUT THE DURATION OF THE CONVERSATION WAS AT TIMES SLURRED AND HIS BEHAVIOR WAS CYCLIC.

OFFICER DESANTIS LOCATED A PROJECTILE ELECTRONIC DEVICE/TASER THAT WOULD HAVE BEEN READILY ACCESSIBLE TO GUERRA AS THE DRIVER AND WAS IN CLOSE PROXIMITY TO THE CENTER CONSOLE WHICH WAS WITHIN REACHING DISTANCE. THE DEVICE WAS LATER TESTED BY OFFICER VANHORN. IT WAS OPERABLE AND READY TO FIRE. OFFICER VANHORN TOOK PHOTOGRAPHS OF THE VEHICLE AND RIM OF THE VEHICLE. THE PARENTS AGAIN BEGAN INTERFERING AND CAUSING A SCENE. FOR SCENE SAFETY I DECIDED TO PLACE GUERRA UNDER ARREST FOR THE MARIJUANA AND SUSPICION OF DUI AND WOULD CONDUCT THE FIELD SOBRIETY EXERCISES AT THE STATION.

UPON ARRIVAL AT THE STATION OFFICER DESANTIS CONDUCTED HIS INVESTIGATION FOR DUI AND CONDUCTED FIELD SOBRIETY EXERCISES INSIDE THE STATION. OFFICER VANHORN PROCESSED THE SEIZED PROPERTY AND EVIDENCE. UPON COMPLETING FIELD SOBRIETY EXERCISES OFFICER DESANTIS TRANSPORTED GUERRA TO THE MANATEE COUNTY JAIL WHERE HE SUBMITTED TO A BREATH ALCOHOL TEST FROM BPD OFFICER J.E. VONADOR WITH RESULTS OF .120 AND .111.

CBD OIL TO BE SENT TO THE LAB FOR TESTING/THIS CHARGE PENDING.

AFTER THE FIELD SOBRIETY EXERCISES WERE CONDUCTED, (GUERRA) BEGAN TO GET MORE AGITATED AS TIME WENT ON. (GUERRA) WOULD NOT ANSWER QUESTIONS REGARDING HIS PERSONAL INFORMATION FOR THE ARREST PAPERWORK. (GUERRA) FINALLY STATED HIS NAME FOLLOWED BY A GROSS RESPONSE OF A RANK AND SERIAL NUMBER. SGT. PIERCE CONDUCTED A CHECK OF (GUERRA'S) CRIMINAL BACKGROUND. (GUERRA) HAD A PAST FELONY CONVICTION IN ILLINOIS. OFC. M. VAHORN ASSISTED ME WITH TESTING, WEIGHING AND PACKAGING THE EVIDENCE. OFC. VANHORN STATED THE BURNT HAND ROLLED MARIJUANA JOINTS TESTED POSITIVE FOR THC, WHICH IS THE MAIN CHEMICAL IN MARIJUANA. OFC. VANHORN STATED THE SEVEN BURNT HAND ROLLED MARIJUANA JOINTS WEIGHED IN AT 1.2 GRAMS.

WHILE I WAS TRANSPORTING (GUERRA) TO MCSO JAIL, (GUERRA) FELL ASLEEP. UPON ARRIVAL TO THE JAIL, (GUERRA) ASKED WHEN HE WAS GOING TO BLOW TO PROVE HE WAS NOT INTOXICATED. ONCE INSIDE THE JAIL, (GUERRA) USED MORE PROFANITY, SPEAKING TO THE CORRECTION DEPUTIES. (GUERRA) COMPLAINED THE ARREST WAS ILLEGAL BECAUSE HE WAS IN HIS DRIVEWAY AND HOW HE WAS GOING TO SUE THE "ASSHOLE" COP THAT WAS BEING "RACIST" AND "HARASSING" HIM. BRADENTON POLICE OFFICER J.E. VONADOR CONDUCTED THE BREATH ANALYSIS ON (GUERRA). (GUERRA) CONSENTED TO PROVIDED BREATH SAMPLES. OFC. VONADOR COMPLETED THE BREATHALYZER PORTION OF THE DUI PACKET. OFC. VONADOR STATED (GUERRA) SPONTANEOUSLY STATED HE HAD CONSUMED THREE ALCOHOLIC BEVERAGES AT 0100HRS AND CONSUMED ANOTHER DRINK WHEN HE GOT HOME. LATER, (GUERRA) SPONTANEOUSLY STATED TO ME THAT HE HAD BEEN DRINKING ALL NIGHT SINCE 2200HRS. OFC. VONADOR PROVIDED TWO BREATH ANALYSIS FORMS, STATING (GUERRA) COULD NOT FOLLOW SIMPLE INSTRUCTIONS, CAUSING SEVERAL ERROR READINGS DURING NUMEROUS ATTEMPTS. THE INSTRUMENT WAS ABLE TO GATHER TWO GOOD SAMPLE READINGS. (GUERRA'S) READINGS SHOWED A .120 AND A.111.

I READ (GUERRA) HIS MIRANDA RIGHTS. WHEN I ASKED IF HE UNDERSTOOD EACH OF THE RIGHTS THAT I READ TO HIM, HE STATED, "I UNDERSTAND YOU'RE A BARNEY FIFE LOOKING MOTHER FUCKER, WITH ONE BULLET IN HIS BREAST POCKET." I ASKED HIM AGAIN IF HE UNDERSTOOD EACH OF THE RIGHTS I READ TO HIM. HE REPEATED THE SAME STATEMENT. WHEN ASKED IF HE WOULD LIKE TO SPEAK TO ME, HAVING THESE RIGHTS IN MIND. HE REPEATED, "I UNDERSTAND YOU'RE A BARNEY FIFE LOOKING MOTHER FUCKER, WITH ONE BULLET IN HIS BREAST POCKET." I CONTINUED DOWN THE LIST OF QUESTIONS ON THE FORM. (GUERRA) REPEATED THE SAME STATEMENT FOR EACH QUESTION. WHEN I ASKED WHAT DIRECTION HE WAS TRAVELING, (GUERRA) STATED, "LAWYER MOTHERFUCKER, LAWYER!" THE QUESTIONS WERE DISCONTINUED. WHILE COMPLETING THE DUI PACKET, (GUERRA) MADE MORE SPONTANEOUS STATEMENTS, POST MIRANDA. (GUERRA) ASKED IF I HAD HIS E-CIG AND THEN STATED IT HAD CBD OIL INSIDE THAT HE USES TO QUIT SMOKING. (GUERRA) STATED TO ME, "ADMIT IT DESANTIS, YOU'RE JUST MAD CUZ I HAVE BETTER WEED THAN YOU." (GUERRA) ASKED ABOUT HIS TASER, STATING WE BETTER NOT USE IT AND THAT HE WILL BE IN TOMORROW TO PICK IT UP. (GUERRA) CONTINUED TO BE AGITATED, ASKING ME QUESTIONS TO GATHER INFORMATION ABOUT THE PRIMARY OFFICER THAT HAD STOPPED HIM. 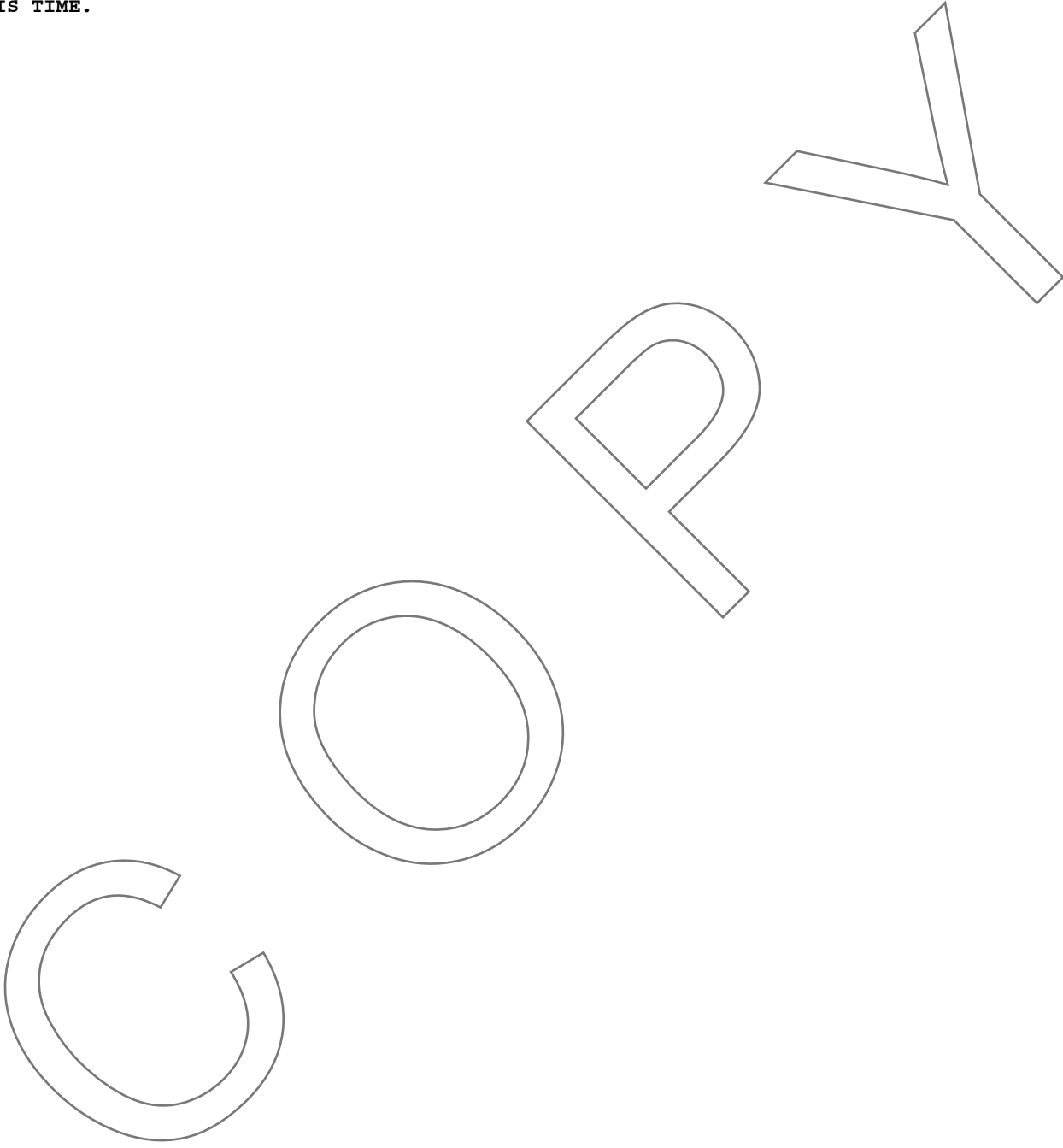
